1. Village Green tree pollarding – scheduled to be done on 27 January
2. Defibrillator – cost in budget for coming year. Need to identify location
3. Ure Bridge lighting project. Awaiting further action from Boroughbridge Town Council
4. Potholes, specifically St John's Walk and Church Lane. Clerk to contact NY Highways Area 6
5. Electoral Register 2020/21 received by clerk. Now **758*** electors in parish, broken down as follows:
 - Kirby Hill 345** (new address - Evesham Place)
 - Milby 333** (new addresses - Hockley Crescent, Kirby View, Owl Place, Pasture Close, Swale Close & Wren Drive)
 - Humberton 34**
 - Ellenthorpe 24**
 - Thornton Bridge 22**(*2019/20 register contained 523 electors, so a 45% increase!)
